## PRIVATE FLYING CLUB

POLICY AND PROCEDURE FOR ACCEPTANCE IN BLUE SKY FLYERS INC. EFFECTIVE May 2007.

1. Applicant will fill out an Application and a Membership Agreement to be turned in with a \$50 application processing fee.
2. Blue Sky Flyers Inc. is to have up to two weeks to make a credit check
3. If the applicant has prior flight experience, he/she must present themselves for a flight evaluation check ride with the chief flight instructor or his assignee. The applicant is responsible for the cost of the aircraft flight time and instructor.
4. Upon acceptance, the applicant will be required to purchase one share of stock before continued flight is allowed, provided a share is available from the club or from a retiring member. If no shares are available, the applicant will be placed on a waiting list.
5. Upon termination from the club, the retiring member must return any club property and keys and pay any indebtedness before a transfer of his share of stock to a pre approved new applicant will be allowed.
6. Attach a copy of your current medical certificate. All applicants must have completed a medical exam, have a current medical certificate and include a copy of it in the application.
7. Attach a copy of your Pilots license or Student license.
8. Attach a copy of the page of your log book with the most recent Flight Review endorsement for FAR 61.56.
9. Attach check for \$50 application processing fee to Blue Sky Flyers Inc. This fee is in addition to the cost of a share of stock.
10. Attach a copy of Driver's License
11. Attach a copy of birth certificate or passport.
12. Attach Membership Application and Membership Agreement.

# Blue Sky Flyers

## MEMBERSHIP AGREEMENT

AGREEMENT made this \_\_\_\_\_ day of 20\_\_\_\_ between and among all the existing members of BLUE SKY FLYERS, and all future members as such membership is shown in the records of BLUE SKY FLYERS from time to time. The deletion of former members or the addition of new members does not need to be ratified by any member and shall not affect the validity, enforceability or requirements of this Agreement.

Upon good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned agrees to the following terms, conditions and requirements of membership:

1. **Stock.**

A. Each member shall own one (1) share of stock which shall be paid in full (currently \$1000) or be subject to an installment payment agreement approved by the Board of Directors.

B. A share of stock may be sold by a member to a new person only if the new person is accepted for membership by BLUE SKY FLYERS, and signs and fully complies with the Acceptance Notice And Requirements For Membership.

C. A member desiring to sell his or her share of stock may notify BLUE SKY FLYERS and the member's name will be placed on a list in the order in which the request is received. A new member obtained by BLUE SKY FLYERS shall be substituted for the oldest such request. Alternately a member may find a buyer for his/her stock who must be approved by the board for membership.

D. For other terms of leaving BSF see the Bylaws XVI sections #2 and #3

E. A member may be expelled by the Board of Directors. Ten (10) days notice shall be given to each member who shall have the right to be heard either in person or by counsel at a meeting of the Club called for this purpose. A member so expelled shall receive from the Club a sum equal to the current price of the stock less any monies, dues or fines owing the Club.

2. **Monthly Dues and Other Charges.**

A. Each member shall be responsible for his or her monthly dues as may be modified from time to time in accordance with the Bylaws For BLUE SKY FLYERS and shall *continue to be* responsible therefore *until* BLUE SKY FLYERS is dissolved or until said member is replaced by a new member or expelled in accordance with the terms of this Membership Agreement, the Bylaws for BLUE SKY FLYERS and/or the Acceptance Notice And Requirements of Membership.

B. Each member hereby agrees and understands that becoming a member in BLUE SKY FLYERS will have the effect of a member being legally obligated to pay monthly dues for a potentially long period of time after the member desires to resign or discontinues flying until said member is replaced by a new member or expelled in accordance with the terms of this Membership Agreement

C. Each member hereby further agrees that in the event BLUE SKY FLYERS pursues collection of delinquent dues from a member, the member shall be fully responsible to

pay all of the delinquent dues, interest thereon at the rate of 1.5% per month (18% per annum.), court costs and reasonable attorney's fees.

D. Monthly dues shall be paid on or before the last day of each month.

E. Monthly dues are currently \$76.00 (6-08). There is a minimum flight charge each month of \$15 for less than one hour of flying in a month.

F. Members flying more than 3 hours per year are required to contribute 3 hours per year toward upkeep of the planes and clubhouse. Those not contributing will be billed \$25/hr up to \$75

G. Each member is charged \$20 for a slush fund to cover "dings" caused by members that are not covered by or reported to the insurance company. The charge will not be made again until the fund is depleted.
